The Society is a 501(c)3 non-profit organization. Our tax ID # is 95-353-9454.

The Society provides the following for these events -

- White garden chairs and VIP portable lavatory facilities
- Outdoor electrical connections and trash receptacles
- A beautiful replica of a 17th century Vis-a-vis white carriage if requested

The Responsible Party agrees to the following –

- Full payment 90 days prior to the scheduled event
- Liability Insurance Coverage for 1M is required. The Responsible Party must provide a one-day Certificate of Insurance with the South County Historical Society listed as the *additionally insured party*.
- Hold Harmless Agreement
- A Donation to the Society is required. All donations are used for the maintenance and preservation of the Society’s programs.
- Agreement to the City Ordinances regulating use of the properties
